

TERMS AND CONDITIONS

1. INTRODUCTION: Welcome to G-Field Recorder (the "App"). This App is published by or on behalf of Stratos Perception LLC ("Stratos" or "We" or "Us") a company registered in Texas USA, contact at P.O. Box 3614, Houston, TX, 77253.

By downloading or otherwise accessing the App you agree to be bound by the following terms and conditions ("Terms") and our privacy policy. If you have any queries about the App or these Terms, you can contact Us by any of the means set out in paragraph 13 of these Terms. If you do not agree with these Terms, you should stop using the App immediately.

2. GENERAL RULES RELATING TO CONDUCT: The App is made available for your own, personal use. The App must not be used for any commercial purpose whatsoever or for any illegal or unauthorized purpose. When you use the App you must comply with all applicable United States Of America ("USA") laws and with any applicable international laws, including the local laws in your country of residence (together referred to as "Applicable Laws").
